

The Championships 2018: Tennis Foundation Rules

The following rules must be adhered to by any organisation or individual receiving tickets through any ballot or offer administered by the Lawn Tennis Association (LTA) on behalf of the Tennis Foundation (TF).

Schools Ballot Eligibility Requirements only

A school is eligible for the TF Schools Ballot if it meets the following criteria by midday on 18 January 2018.

- The school is a fully paid member of the TF's Schools Tennis Membership; and
- The school has opted in to the TF Schools Ballot by 18th January 2018.

Schools who become members after the 18th January 2018 will not be eligible for the TF Schools Ballot for 2018.

Schools must ensure they are current members of the Schools Tennis Membership when they Opt In and on the date of Opt In deadline – 18th January 2018.

To Opt In to the Schools Ballot you must log into your school's membership account on the TF website, go to Wimbledon Ballot and Schools Details and then choose your Wimbledon Ballot preferences.

You may choose up to 3 days that you are able to attend and if you would also like to apply for Centre Court tickets. Once you have received a ticket offer, you cannot make any changes to your preferences.

Rules – Applying to All Tennis Foundation Wimbledon Tickets

1. Tickets are issued subject to The All England Lawn Tennis and Croquet Club (AELTC)'s Conditions of Sale. The Conditions of Sale are agreed to at the time of purchase and are available in full at: https://www.wimbledon.com/en_GB/tickets/conditions_of_sale.html

Please note that any individual who advertises, offers for sale or sells tickets (or who transfers tickets not in accordance with the AELTC's conditions of sale) may not be permitted to apply for or receive tickets from the AELTC or its authorised agents (including Ticketmaster) (for a period of 5 full Championships from the date of such breach).

2. Any ticket advertised or offered for sale whether by an applicant or any third party will be void.
3. Under no circumstances should tickets be given away or used by anyone outside of the individuals or organisation they were assigned to.
4. Tickets shall not be:

- (a) used for any promotion, advertising, fundraising, auction, raffle or any other similar commercial or non-commercial purposes;
- (b) used as a prize (or part of prize) in any contest, competition, promotional game of chance, lottery or sweepstake.
- (c) combined with and sold or transferred as part of any package of goods or services; or
- (d) combined with and sold or transferred as part of any travel, accommodation or hospitality package.

5. Refunds/Returned Tickets

In the event that an organisation has purchased tickets and are then unable to use any tickets issued to them, they must request a refund from the LTA. If through a Tennis Foundation Wimbledon ticket offer, the tickets have been assigned as a pack of tickets, we will only be able to process a refund on all tickets purchased as part of the offer. The LTA cannot issue a refund on individual pairs. Whilst the LTA will accept and refund the price (face value) of such tickets, ALL tickets must be returned to the LTA at least 24 hours before the date for which such tickets are valid, in order to receive the refund.

Terms and conditions

Schools Membership terms and conditions are provided for all schools. These are available at: <http://www3.lta.org.uk/Tennis-Foundation/My-Schools-Tennis/Profile/> and agreed to upon registering for Schools Membership.

Any organisation or individual found to be in breach of these rules may have the option to enter the ballot removed in future years.

These rules apply to all organisations or individuals who receive an allocation of tickets from the LTA or Tennis Foundation in 2018. Tickets remain the property of the AELTC at all times and the LTA retain overall responsibility for all tickets.

Any decision made by the LTA regarding tickets is final.
