

# The Championships, 2017

## Tennis Foundation Rules

The following rules must be adhered to by any organisation or individual receiving tickets through any Ballot or ticket offer administered by the Lawn Tennis Association or Tennis Foundation.

### Rules

1. Tickets are issued subject to the AELTC's Conditions of Sale. The Conditions of Sale are agreed to at the time of purchase and are available in full at: <https://www.lta.org.uk/major-events/grand-slams/wimbledon/ballots/>
2. Any ticket advertised or offered for sale whether by an applicant or any third party will be void.
3. Under no circumstances should tickets be given away or used by anyone outside of the individuals or organisation they were assigned to.
4. Tickets shall not be:
  - (a) Used for any promotion, advertising, fundraising, auction, raffle or any other similar commercial or non-commercial purposes;
  - (b) Used as a prize (or part of prize) in any contest, competition, promotional game of chance, lottery or sweepstake.
  - (c) Combined with and sold or transferred as part of any package of goods or services;  
or
  - (d) Combined with and sold or transferred as part of any travel, accommodation or hospitality package.
5. Refunds/Returned Tickets  
In the event that you have purchased tickets and are then unable to use any tickets issued to you, you must return all tickets assigned to the LTA or Tennis Foundation. Whilst the LTA will normally accept and refund the price of such tickets (provided that the tickets are returned at least 24 hours before the date for which such tickets are valid), the LTA shall not be bound to do so.

### Schools Ballot Eligibility Requirements

A School is eligible for the Schools Ballot if it meets the following criteria by midday 20 January 2017.

- The School is a paid member of the Schools Tennis Membership; and
- The School has Opted In to the Schools Ballot by 20 January 2017.

Schools who become members after the 20 January 2017 will not be eligible for the Schools Ballot in 2017.

Schools must ensure they are current members of the Schools Tennis Membership when they opt in and on the date of opt in deadline – 20 January 2017.

Annual membership costs £15 a year for primary schools and £35 a year for secondary schools.

To opt in to the Schools Ballot you must log into your schools membership account on the TF website, go to Schools Details and then choose your Wimbledon Ballot preferences.

You may choose up to 3 days that you are able to attend (or any day) and if you are interested in Centre Court tickets.

### Terms & Conditions

Any organisation or individual found to be in breach of these rules may have the option to enter the ballot removed in future years.

These rules apply to all organisations or individuals who receive an allocation of tickets from the LTA or Tennis Foundation in 2017. Tickets remain the property of the AELTC at all times and the LTA retain overall responsibility for all tickets.

Any decision made by the LTA regarding tickets is final.
